TOURNAMENT CONDITIONS

1. **Tournament Dates:** Saturday January 28th and Sunday January 29th, 2012.
2. **Times of Play:** Play will commence at 9am each day and will conclude by official sunset. Entrants must be available for the entire weekend of the event.
3. **Eligibility:** Entrants must be a current member of a SSTA affiliated club.
4. **Entry Forms:** All players must submit an entry form by the closing date.
5. **Entry Fees:** Entry fees must accompany entry forms by close of entries (5pm Friday 20th January). Entry fees will only be refunded in extenuating circumstances.
6. **Event Format:** All events will be round robin format, and no division shall contain more than eight (8) pairs. A play-off between group winners may be played depending on entries, or win/loss ratio to determine event winners at the discretion of the match committee. Groups will be drawn according to combined ratings/grades at the discretion of the tournament committee. Matches will be run to time.
7. **Format of Play:** Match format will be round robin timed matches with short deuces
8. **Draw:** The draw and schedule of play will be on display at Higgins Park Tennis Club and accessible from the club website: www.tennis.com.au/higginsparktennis from no later than Wednesday 25th January.
9. **Balls:** New Slazenger balls will be issued at the discretion of the match committee.
10. **Reporting:** Players are required to report to the tournament office by 8:30am to run through the format of play, irrespective of weather conditions. Should a player fail to report by the scheduled time of the match, the player may be defaulted by the match committee.
11. **Tournament Committee:** The tournament committee shall have entire control of the tournament and reserves the right to make such changes and decisions deemed necessary to complete the tournament.
12. **Conditions of Entry:** By submitting an entry form, players agree to abide by the above tournament conditions and understand that the decision of the tournament referee is final.
